Was seen in the ER at Anywhere Hospital in Anywhere, TN. for the seizure and was treated and released. P/I talked to the Dr. at the ER and since she told him about the alcohol after the medication was started, he thought that maybe the seizures has something to do with the withdrawal from alcohol. She states that she can be weaned off the medication due to this fact. The seizures happened after she was saved not at the same time. No alcohol program. No drug usage. Compliant with medication.
9c/10	Dr. XXXXX Psychiatrist in Anywhere, TN. seen last 10-1-2010 for ADHD and PDD. Diagnosed 2-2010. Symptoms of panic attacks, did not want to get out of bed. Could not concentrate. Brought on by ? Said she had the ADHD previously

and that one of her sons has the same symptoms. States that there are no problems eating or sleeping. No mood swings or crying spells. States that she has a panic attack after a car accident 5 years ago and since then 2-3 times a year. Muscles would draw up, couldn't move, felt helplessness. States that a paper bag does not work for the Panic attack only a clear mask. Doesn't know why. Last panic attack was when she had a pap smear 6 weeks ago due to pain because she had a 3 1/2 cm cyst on her right ovary and it ruptured. Resolved cyst. No F/H of mental disease or disorder. No cause determined. Seen in the ER several times and the last time was 6 weeks ago after pap. Anywhere Hospital in Anywhere, TN. Suicidal thoughts when she was drinking last time was 3-09, Seen at Anywhere Hospital in Anywhere, TN. Treated and released. Did not miss work or have job duties modified due to this condition. Takes adderall 30 mg 2 times a day and alprazolam 1 mg 2 times a day. No adjustment in medication. Controlled.

Alcohol abuse, "saved" 8-22-2010, no formal program. No drinks since that time.
